i) <u>In the matter of Matathwada Shikshan Prasarak Mandal's Shri Shivaji</u> <u>Institute of Engineering and Management Studies Parbhani for approval</u> <u>of fees for the A.Y. 2012-13 to 2016-17.</u>

Read communication dated 19/10/2018 received from the Institute.

The Institute submitted fees proposal for the A.Y. 2011-12 to the then Shikshan Shulka Samiti. The Shikshan Shulka Samiti approved Rs. 47,180/- as fee structure for A.Y. 2011-12. The institute was not interested in upward revision for the subsequent academic years. Decision of Shikshan Shulka Samiti dated 9/1/2013 is relied upon by the institute. Since Rs. 47,500/- was the Government approved fee structure for B. Engineering course, Shikshan Shulka Samiti allowed the institute to collect same amount of fees without submitting fees proposal. In that view of the matter approach of the institute in collecting the said amount of fees in the A.Y. 2012-13, 2013-14, 2014-15 and 2015-16 cannot be faulted with.

Ar CX

This Authority after resuming its function invited joint proposals for A.Y. 2016-17 and 2017-18. Pursuant to that the institute submitted fees proposal and in that opted for "no upward revision" for A.Y. 2016-17. This Authority, accordingly approved fees structure for A.Y. 2017-18 and did not interfere with choice of "no upward revision" given by the institute relating to fees of A.Y. 2016-17.

Having considered the issue in the above back drop, no fault lies with the institute. Whatever fees collected during the period from 2012-13 to 2016-17 was government approved fees. However request of the institute to approve the fee structure for previous academic years cannot be accepted. Narration of events reveal that fees for A.Y. 2011-12 was approved and thereafter as per norms / policy decision of Shikshan Shulka Samiti the institute collected Government approved fees for the A.Y. 2012-13 to 2015-16. This Authority has jurisdiction to approve fee structure after proposal is submitted. Proposals for said academic years were not submitted and were not required to be submitted as per policy decision of the then Shikshan Shulka Samiti. Accordingly the institute was authorized to collect Government approved fees of Rs. 47,500/-. As regard fees for A.Y. 2016-17 fees of previous academic year deemed to have been approved, by this Authority.

In view of the above show cause notice dated 15/10/2018 stands discharged. Request of the institute, to approve fee structure, for A.Y. 2012-13 to 2016-17 being redundant is disposed of.

It is hoped that, the Department concerned will appreciate situation in its right perspective and consider the case of institute for reimbursement according to law.

ii) In the matter of KLE Society's KLE Law College, Kalamboli, Navi Mumbai regarding fixation of the fees for AY 2016-17 and 2017-18.

Read communication dated 4/1/2019 received from the college.

The college started in the A.Y. 2016-17. Courses conducted by the college are BLS LLB 5 years and LLB 3 years. The college collected Rs. 23,450/- from the students in A.Y. 2016-17 and 2017-18 batches. The fee proposal for A.Y. 2018-19 was considered by this Authority and fees of Rs. 35,000/- was approved. Having considered the same, the fees of Rs. 23,450/- collected by the college from the students in A.Y. 2016-17 and 2017-18 batches appear reasonable and is accordingly approved.

In the matter of Vivekanand Shikshan Prasarak Mandal's V.B.N Nursing School, Hingoli regarding fees for AY 2018-19.

Read communication dated 17/11/2018 received from the Institute.

Pursuant to the fee proposal submitted by the institute for the A.Y. 2019-20, this Authority in its meeting dated 2/12/2018 approved Rs. 33,000/- as fees for A.Y. 2018-19. The institute did not prefer review application. Communication dated 17/1/2018 cannot



be treated as review as it is beyond period of limitation. On the basis of Income and Expenditure statement and the practice of payment of salary in cash, fee structure has been approved. It is stated by the institute that now they have started making payment through bank. This does not rectify the past irregularity. The fact that the institute is now making payments through bank would be considered, while deciding fee proposal for 2019-20.
