# **CLAUSE 1**

### **CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives and they shall establish cooperation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

## CLAUSE 2

# SCOPE OF THE MOU

- 2.1 Aptitude Training: AVR and Institution interaction will provide an insight into the latest developments / technologies / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to interact and involve in Training Programs for the First Party. This will provide confidence & smooth transition for students work. Also, the Second party may register on the AICTE Internship Portal for the benefit of students.
- 2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the recent aptitude tests, examination trends and in house requirements.
- 2.3 Placement of trained students: second party will actively engage to its best capability to help the delivery of the virtual and offline training and placement support of the students of the first party on the technology trends and in house requirements.
- 2.4 There is no financial commitment on the part of the **Institute of Pharmacy and Research**, **Badnera** the first party to take up any program mention in MOU. If there is any financial consideration, it will be dealt separately.
- 2.5 Both Parties to obtain all internal approvals, consents, permissions and licenses of whatsoever nature required.

CLAUSE 3 VALIDITY

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms. Any act on the part of both the Parties after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU. The validity of the MoU may however be for two years.

3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

#### CLAUSE 4

#### RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors and the relationship established under this MOU shall not be construed as a partnership.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by mutual discussion.
