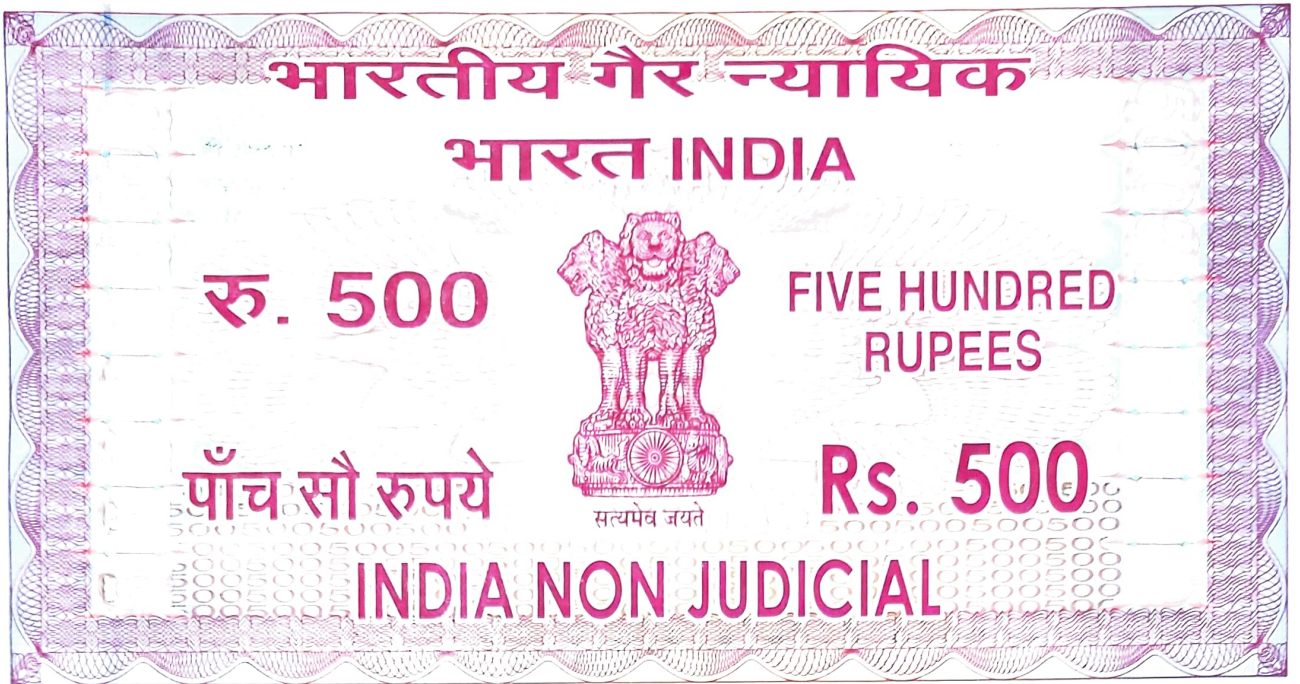

BETWEEN

Institute of Pharmacy and Research, Badnera established on/in 2017 under the Parent Body Vidharbha Youth Welfare Society, Amravati, having its campus at New Express Highway, Anjangaon Bari Road, Badnera -Amravati, hereinafter referred to as "**College**", represented by its Principal as the Party of the First Part.

AND

Maharashtra Knowledge Corporation Limited, a Public Limited Company incorporated under the Companies Act, 1956 having CIN U80302PN2001 PLC135348 and having its registered office at International Convention Center (ICC) Trade Towers, A Wing, 5th Floor, Senapati Bapat Road, Shivajinagar, Pune 411016, Maharashtra, INDIA, hereinafter referred to as "**MKCL**", represented by its Managing Director as the Party of the Second Part.

AND WHEREAS the College is, therefore, desirous forging collaboration with a few reputed organizations, hereinafter referred to as 'Knowledge Partners', who are having long-standing and proven track-record of offering high quality courses in multiple disciplines which on one hand will give wider and choice-based developmental exposure to its students in a flexible manner and on the other hand contribute towards the empowerment of students by imparting knowledge, skills, attitudes, and values and enhance their employability in various sectors of economy,

AND WHEREAS MKCL was promoted by the Department of Higher and Technical Education, Government of Maharashtra, and several state public universities have been MKCL's initial shareholders,

AND WHEREAS MKCL has mapped these courses to develop students to take up specific industry roles in various sectors of economy. As a result, these courses form a *bridge from college to careers*,

AND WHEREAS MKCL, as per NCrf 2023 and NHEQF 2023, has creditized its courses at various Credit Levels and is offering hundreds of credits under its '*iLike*' Brand which stands for "*Incredible Learning Innovations for Knowledge Empowerment*",

AND WHEREAS MKCL is desirous of including *iLike* Credit Courses (designed by academically consistent grouping one or many *iLike* credits in logical sequences) in various Certificate, Diploma, Degree, and Post-Graduate Degree Programs of the College based on their suitability to the College in overall interest of its students,

AND WHEREAS the College as the Recognition and Joint Certification Partner and MKCL as a the Knowledge Partner and the College as *iLike* Computer Labs Provider i.e., the Academic Implementation Partner can collaborate to offer *iLike* Credit Courses as choice-based electives to the students under any of the Course Groups stipulated in NCrf 2023 such as Major (Mandatory), Major (Elective), Minor, Open / Generic Elective, Vocational and Skill Enhancement, Ability Enhancement, Value Education / Life Skills, etc. as per the nature of the program in which a particular *iLike* Credit Course will be considered for offering to the students towards the partial fulfilment of their Certificate, Diploma, Degree Program, or Post-Graduate Degree Program of the College,

NOW THEREFORE with a view to synergize their strengths in the interest of the student community, the parties hereto agree to enter into a Memorandum of Understanding (hereinafter referred to as '**MoU**') specifying the scope, their rights, responsibilities and arrangements as herein below:

(1) Details of *iLike* Credit Courses:

"iLike" means MKCL's 'incredible Learning Innovations for Knowledge Empowerment'.

The objectives and outcomes, syllabus, learning and assessment content, environment, and process, and evaluation content, environment, and process of *iLike* Credits are designed and developed and regularly updated by MKCL to empower students with relevant actionable knowledge, skills, attitudes and values for responding to the emerging challenges and opportunities confidently. These credits are offered in a computer lab-based eLearning mode through MKCL's homegrown Learning, Assessment and Evaluation Management System (ERA – eLearning Revolution for ALL),

2. Recognizing in April every year, the above mentioned MKCL's iLike Credits through appropriate bodies and authorities of the College for the award of these Credits to the students towards partial fulfilment of various academic programs of the College for which the students will be enrolled in the College Campus for the ensuing academic year from say, July every year.
3. Performing the role of Joint Certification Partner with MKCL.

(4) Role of the College as iLike Labs Provider / Academic Implementation Partner (AIP) in Offering iLike Credit Courses:

1. Academic Delivery Partner

MKCL share above is exclusive of GST. GST shall be additional like for 1 Credit MKCL fee will be Rs.300/- plus 18% i.e. Rs.354/-; 2 Credits will be Rs.600/- plus 18% i.e. Rs.708/-; 3 Credits will be Rs.900/- plus 18% i.e. Rs.1,062/- and 4 Credits will be Rs.1,200/- plus 18% will be Rs.1,416/-.

**** Student shall mean the individual who has registered for an iLike Credit with the iLike Lab and has paid to the iLike Lab the amount of Fee Share of MKCL as shown above. Student shall get MKCL's ERA LMS Login only after the Full Fee Share of MKCL^{***} is electronically transferred to MKCL bank Account by the College as iLike Labs Provider or AIP (A software utility and training will be provided by MKCL to the iLike Lab Coordinator for this purpose).**

***** Student Login for each iLike credit course shall be valid for 180 days from the date of its generation or until successful completion of the iLike credit whichever is earlier.**

(6) General Terms and Conditions:

1. All intellectual property rights including but not limited to course names, content, methodologies, software frameworks, assessments, and related materials—whether in printed or electronic format—developed or provided under this MoU shall remain the exclusive property of MKCL. This includes any design, documentation, or digital assets forming part of the iLike Credits. Third-party components licensed by MKCL shall remain the property of the respective licensors.
2. Each Party agrees to maintain the confidentiality of all proprietary and sensitive information received in connection with this MoU and shall not disclose or use such information except as required for the performance of its obligations under this MoU. This obligation shall survive the termination of the MoU.
3. Each Party shall comply with applicable data protection laws in the collection, processing, and handling of personal data under this MoU and shall ensure that such data is used solely for the purposes of this MoU, with appropriate security measures to protect its confidentiality and integrity.
4. All candidate data collected under this MoU shall remain the exclusive property of the College. MKCL shall act solely as a data processor and shall process such data only for the purposes expressly stated in this MoU, including academic delivery, learner management, certification, and reporting, with appropriate safeguards to ensure confidentiality and data integrity. The College shall be solely responsible for obtaining the necessary consent and authorizations from the candidates for the collection, use, and processing of their personal data in accordance with applicable laws.
5. This MoU shall be effective from the date of signing and shall be valid unless terminated by either party, subject to renewal and mutual amendments or updation with consent by both parties.
6. This MoU may be terminated either by mutual consent of both parties or by either party providing the other with a written notice of three calendar months. Such termination shall not affect any commitments made prior to the notice date, and both parties shall ensure the completion of any ongoing obligations to avoid tangible losses to the other party.

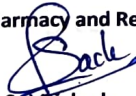
7. Each Party agrees to indemnify, defend, and hold harmless the other Party and its officers, employees, and agents from and against any claims, liabilities, losses, damages, or expenses (including reasonable legal fees) arising out of or related to any breach of this MoU, violation of applicable laws, or negligent or willful misconduct by the indemnifying Party or its representatives.
8. Any disputes arising out of this MoU shall be settled amicably through negotiations in good faith, failing which the same shall be referred to arbitration by a sole arbitrator to be appointed by the Parties with mutual consent, in accordance with the provisions of Arbitration and Conciliation Act, 1996 and subsequent amendments thereof. This clause shall survive expiration or earlier termination of this MoU. The place of arbitration shall be at Pune and shall be conducted in the English language.
9. Each Party represents and warrants that it has the full authority and legal capacity to enter into and perform this MoU, that its execution and performance will not violate any applicable laws or third-party rights, and that it shall comply with all applicable statutory and regulatory requirements during the term of this MoU.

(7) Notices

Any notices, requests and other communications required or permitted hereunder shall be in writing and shall be given by hand against written acknowledgement or receipt or sent by email at or to each of the parties at the addresses set forth below in this MOU or to its last known place of business.

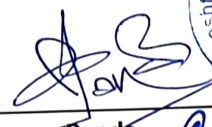

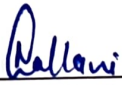
